RE: KSSOW - ELCID, and reporting to managers

Utah MSP Program Information for Managers – Knowledge Services

KSSOW (Knowledge Services Scope of Work) Number

Note: KSSOW number is assigned after approved by DTS Contracts

The first numbers in KSSOW = FY. Example KSSOW 26...was approved in FY26

The numbers that follow are in order. KSSOW 26001 is the first project approved in FY26

Once a project request is approved by DTS contracts, this project will have an estimated budget and estimated end date.

- No max budget but project spend must always be under the approved budget for compliance.
- The length of the project can be any duration, up to 5 years. (Max project durations:
 5 years)
- KSSOW numbers can have amendments. Additions to work needs, budget or duration.
- ELCID's do not require amendments but an email request to add, change or remove

Monthly - Quarterly report sent to DTS Managers

- Monthly ELCID spend report Typically the second week of the following month, you will be emailed your FY to date ELCID spend report.
 - Dollars spent in July are emailed in August. Dollars spent in July/August are emailed in September. (Running total, FY to date spend)
- Quarterly KSSOW report
 - Each quarter completed, this MSP will email you the total project spent. The goal is information sharing and to provide updates of project to remain compliant with the terms of the Contract IT2462
 - This will let you see the start and end date
 - The total project approved amount
 - Project spend total and the remaining budget.

Possible misunderstanding on KSSOW projects is duration. You can set a duration under 5 years, but the project will not need to be open to competitive bidding, if you would like to extend the duration. Only an amendment is needed.
